董事總經理寄語 MESSAGE FROM MANAGING DIRECTOR

這個蛇年將是靈活思變、巧妙轉身的一年。讓我們一起努力識變、應變、求變,共創商機!祝願各位朋友、客戶、同事,身體健康事事順意!

Time flies and we are now stepping into year 2025, whilst waving goodbye to the year of Dragon and welcoming the year of Snake!

In Chinese, there is an idiom of "The chaotic mix of Dragon and Snake", which means a place with both clever and ignorant people. At this moment, Hong Kong, as well as other regions are exactly under the influence of a mix of clever and less sensible decisions from world leaders. Our SAR Government is endeavouring by spending the past accumulated reserve to maintain the stability of the society, as well as to speed up the economic transformation to match with the National Development Strategy in promoting high-quality economic force. In addition to competing against time, the biggest challenge, however, is the failure to effectively control costs. With limited investment capabilities from enterprises, the most important question now is how to stimulate domestic demand and contribute to economic growth. One of the potential considerable domestic demand may be generated from the necessary response due to the 'double aging' situation: aging population and aging buildings. Many seniors live in their aging residences with fully repaid mortgages. They are faced with constant water leakage problems, large repair bills, various government building inspection and repair orders, and disagreements among owners. Taking advantage of the downturn in property prices, the opportunity to replace very old properties with newer ones has risen. However, more incentives and support are required to facilitate those silver-hair group to move forward. "Snake" in Mandarin sounds like the word "let go". This situation matches with another interesting idiom: "Where there is sacrifice, there is gain" . How to find clever ways to activate this silver-hair economy business opportunity has become a topic studied by many clients. There are other hot topics which we are actively discussing with clients, such as the compliance action to fulfill ESG, impacts to be generated due to the move for Hong Kong to become hubs for International IT and post-secondary education, and changes in supply and demand brought about by continuous talent recruitment from overseas and the mainland.

Snake gives us the impression of flexibility and clever turnaround. So the year of Snake should be the year for us to work together to recognise, respond to and seek changes and create business opportunities.

《政府租契續期條例》下的第二份「續期公告」刊登

地政總署在2024年底根據《政府租契續期條例》(第648章)(《條例》)刊登第二份「續期公告」,涵蓋2031年內到期而沒有續期權利的「一般用途地契」(即一般住宅、商業、工業地契,「適用地契」),涉及一個九龍及兩個港島的地段,主要為住宅用途,全部獲得續期50年。獲續期的地契無須補地價,只須每年繳納相當於有關土地應課差詢租值百分之三的地租。《條例》於2024年7月5日生效,設立常設法定機制,分批為生效日或之後到期而沒有續期權利的適用地契,處理地契續期事宜。連同第一份「續期公告」,政府已為由2024年7月5日至2031年年底到期的地契續期。下一份「續期公告」會在2025年年底前刊登,按照《條例》給予6年通知要求,以處理在2032年內到期的適用地契的續期事宜。

Second "Extension Notice" Published under Extension of Government Leases Ordinance

By the end of 2024, the Lands Department published the second "Extension Notice" under the Extension of Government Leases Ordinance (Cap. 648), covering general purpose leases (i.e. general residential, commercial, industrial leases, hereafter "applicable leases") which expire in 2031 and do not contain a right of renewal. The 3 lots involved in this batch, 1 in Kowloon and 2 on Hong Kong Island, mainly for residential use, have been extended for a term of 50 years. Land leases extended under the Ordinance do not require payment of additional premium, but are subject to an annual payment of Government rent equivalent to 3% of the rateable value of the relevant land. The Ordinance, which came into effect on July 5, 2024, establishes a standing statutory mechanism for handling lease extension matters for applicable leases that do not contain a right of renewal and expire on or after the effective date in batches. Including the first "Extension Notice" published, the Government has extended leases expiring from July 5, 2024 to the end of 2031. The next "Extension Notice" will be published by the end of 2025, covering applicable leases expiring in 2032, in accordance with the requirement under the Ordinance to give 6 years' prior notice.

面對ESG納入估值的挑戰

國際估值準則委員會(IVSC)於2024年11月舉辦了香港會議,這標誌著疫情後估值專業人士的回歸。會議主題為「在不斷變化的環境中應對估值挑戰:平衡全球標準、可持續性和創新」,吸引了來自世界各地的參與者和本地同業,討論關鍵的估值問題。

討論重點集中在市場波動、IVSC標準與中國評估協會在香港框架內的整合,以及人工智能對估值實踐的 影響。與會者特別關注環境、社會和治理(ESG)因素,這些因素現在對<mark>評估資產的長期</mark>可行性至關重 要。與會者認為ESG考量對於在當今市場中保持競爭優勢至關重要。

將ESG納入估值的一大挑戰是可用數據的不一致性和質量,這使得估值專業人士評估重大風險變得複雜。 此外,調整傳統財務方法以考慮ESG影響,例如修改折現率,也帶來了額外的複雜性。

隨著2025年的到來,估值專業人士必須保持對不斷演變標準的敏感性。IVSC 為促進對話和建立強有力的框架而做出的持續努力對於駕馭這一複雜局面和提高 ESG 估值的可信度至關重要。

Facing the Challenge in Encorporating ESG into Valuations

The International Valuation Standards Council (IVSC) held its Hong Kong Conference in November 2024, marking a pivotal return for valuation professionals post-pandemic. The conference, themed "Navigating Valuation Challenges in a Changing Landscape: Balancing Global Standards, Sustainability, and Innovation," attracted participants from around the world and local stakeholders to discuss key valuation issues.

Discussions centered on market volatility, the integration of IVSC standards with the China Appraisal Society within Hong Kong's framework, and the impact of artificial intelligence on valuation practices. A significant focus was placed on Environmental, Social, and Governance (ESG) factors, which are now essential for evaluating an asset's long-term viability. The consensus among professionals is that ESG considerations are critical for maintaining competitive advantage in today's market.

Despite the emergence of guidelines for ESG integration from international bodies and local regulators, concerns were raised about the gaps between expectations and practical implementation. The financial sector faces heightened scrutiny regarding ESG practices, necessitating clear benchmarks for assessing how these factors affect asset values across various domains.

A major challenge in incorporating ESG into valuations is the inconsistency and quality of available data, complicating valuation professionals' assessments of material risks. Furthermore, adapting traditional financial methodologies to account for ESG impacts—such as modifying discount rates—presents additional complexities.

As we approach 2025, it is crucial for valuation professionals to remain responsive to evolving standards. The IVSC's ongoing efforts to facilitate dialogue and establish robust frameworks will be vital in navigating this complex landscape and enhancing the credibility of ESG valuations.


